Pursuant to Article 45 of the Statute of the Polytechnic of Šibenik, the Professional Council at its 2nd session held on 4 December 2019, regarding the conditions of enrollment in the 1st year of undergraduate professional studies at the Polytechnic of Šibenik in the academic year 2020/2021 based on a public tender brought the following

Proposal for a DECISION

on the criteria for enrollment in undergraduate professional studies at the Polytechnic of Šibenik in ac. year 2020/2021

I.

Ranking of candidates for enrollment of students in the first year of undergraduate professional studies conducted at the Polytechnic of Šibenik is carried out based on the evaluation of grades from high school and the results achieved at the state matura.

Candidates are required to have a minimum of B levels from the subjects covered by the compulsory part of the state matura.

For candidates who are citizens of EU member states the first foreign language which they passed as part of their externally evaluated final exam is recognized instead of the Croatian language at the state matura.

Candidates who completed at least four years of secondary education in the Republic of Croatia before 2010 and candidates who completed secondary education outside the Republic of Croatia can take the state matura exams, but they can also apply for the study program if they do not pass the state matura exams, but in that case they do not receive points related to that part of the valuation.


II.

Conditions that will be applied in the classification procedure for enrollment in undergraduate professional studies at the Polytechnic of Šibenik in the academic year 2020/2021 will be valued according to the following ratios:
